## Joinder – Directions for Submitting

- **NOTE:** If you are using the tax liability for you and your spouse, <u>BOTH</u> of you must sign and <u>BOTH</u> Social Security numbers must be listed. However, if one spouse makes significantly MORE than the other, you may wish to have ONLY the higher-earning spouse sign the Joinder WITHOUT having his/her spouse sign.
- 1. There are 2 ways to complete the Joinder:
  - a. On your computer, complete the shaded areas on the appropriate side of the Joinder. (Left side for individuals / Right side for business donations). Make sure all details are accurate since this information will be the basis for the tax document you will receive from us in February 2026. Print out the Joinder and sign it.

- b. Print out the Joinder. Fill in the information on the appropriate side of the Joinder (Left side for individuals / Right side for business donations). Please <u>PRINT</u> legibly, and make sure all details are accurate since this information will be the basis for the tax document you will receive from us in February 2026. Sign the completed Joinder.
- 2. Write the check for your donation payable to the appropriate Penngift SPE, as specified on the Joinder form. Send the completed Joinder, along with your check, to the address shown on the Joinder within the \*allotted time.
- \* The "allotted time" is the date by which you need to return the Joinder and check to the person who provided the Joinder to you. A late submission may result in being placed on a "wait list" for tax credits.
